SPONSORSHIP AGREEMENT

This agreement made as of _____ ("Effective Date") is entered into between THE B-AWARE FOUNDATION acting as host for A-Town Day and _____ ("A-Town Day Sponsor") to support the following activities ("A-Town Day sponsored activities"):

A celebration of the fourth annual A-Town Day (A family day filled with awareness, music, food, fun, and games), to be held on March 20th, 2010 on AUBURN AVENUE in Atlanta, Georgia.

WHEREAS, the A-Town Day sponsor desires to be associated with the A-Town Day activities described above; and

WHEREAS, THE B-AWARE FOUNDATION agrees to associate the A-Town Day sponsor at the desired level of _____ sponsorship and under the terms described below;

NOW THEREFORE, THE B-AWARE FOUNDATION and A-Town Day sponsor hereby agree as follows:

Article 1. Purpose of Agreement

The purpose of this agreement is to describe the nature and scope of the sponsorship activities and the level of _____ participation provided by the A-Town Day sponsor for the second annual A-Town Day.

Article 2. Term of Agreement

This agreement shall commence upon the "Effective Date" and shall extend until the end of the A-Town Day sponsored _____ activities and receipt by THE B-AWARE FOUNDATION of the promised funds.

Article 3. Terms of payment

A-Town Day sponsor agrees to pay THE B-AWARE FOUNDATION the amount of _____ for the _____ sponsorship level. The minimums in Article 4 apply respectively. Payments by the A-Town Day sponsor to THE B-AWARE FOUNDATION should be made in full by December 1st, 2009. In the event your _____ payments are to be made in two installments, the later of the two should be received by February 1st, 2010 at the latest!
